NOTICE OF INTENT TO FILE AMICUS CURIAE BRIEF**

1000 FRIENDS OF FLORIDA, INC. (“1000 Friends”), pursuant to Fla. R. App. P. 9.370(d), hereby gives notice of its intent to seek leave of Court to file an amicus curiae brief on the merits in support of the Petitioners if the Court accepts jurisdiction in this matter.

1000 Friends is a not-for-profit organization founded in 1986 whose purposes include monitoring and ensuring proper implementation of Florida’s growth management laws. 1000 Friends was formed to be a citizens’ voice in growth management issues; to represent persons with standing before local and state boards, agencies, and courts; and to help affected Floridians preserve their

substantial interests in enforcement of such laws. Through the undersigned, 1000 Friends previously appeared in this Court as amicus curiae in *Board of Commissioners of Brevard County v. Snyder*, 627 So.2d 469 (Fla. 1993) which first recognized that local administrative hearings on land development orders should be conducted and reviewable as quasi-judicial proceedings founded on evidence.

The District Court of Appeal has held that in such hearings, only applicants and local governments have a right to cross-examine witnesses. The decision, if not reviewed, affects the ability of 1000 Friends and its members to present or impeach evidence and to preserve objections for meaningful judicial review.
